## **Confidential Dealer Terms**

### **Prices**

- All prices listed are F.O.B. Jonestown, PA
- Prices are subject to revision at any time, should it become necessary.
- Quantity pricing and discounts are only available to bona fide performance parts dealers, BRC Dealers, Stocking Dealers, Special Stocking Dealers, and Chassis builders.

### **Dealer, Stocking Dealer, Special Stocking Dealer, and Chassis Dealer Requirements**

- Dealers must be new or established performance parts merchandisers with interest in oval track racing. Chassis builders must manufacture or assemble either race cars or race car components.
- Parts Dealer – Initial order of \$3,000 dealer cost, excluding freight, is required of all prospective dealers with all parts on this order to be billed and shipped at the same time.
- Stocking Dealer – Initial order of \$5,000 stocking dealer cost, excluding freight, is required of all prospective dealers with all parts on this order to be billed and shipped at the same time.
- Special Stocking Dealer – Initial order of \$10,000 special stocking dealer cost, excluding freight, is required of all prospective dealers with all parts on this order to be billed and shipped at the same time.
- Chassis Dealer – Must buy 3 chassis (in any stage). Special Stocking dealership on parts automatically included.
- Dealerships are evaluated yearly with emphasis on performance in relation to available market area. Minimum yearly purchase may be necessary to maintain dealership status.

### **Order Terms**

- All COD orders must be paid in certified check or money order unless other arrangements are made in advance. Requests for company check acceptance must be accompanied by the proper credit application in order for approval to be considered.
- All truck shipments must be prepaid.

### **Claims**

- Any claim of damage, pilferage or loss in transit must be reported to BRC within 24 hours. We then will start a claim with said carrier and stay involved until situation is resolved.
- Packing must be saved for showing agents of the carrier.
- Any claim for parts shortage must be made within 10 days. Before claiming shortages please note that shortages can be caused by unauthorized persons removing parts before contents are checked in by receiving department or items being overlooked, miscounted, or discarded with packing materials.

### **Returns**

- After a part is installed it cannot be returned.
- Call BRC for a return authorization number
- Return authorization number must be visible on outside of box
- A copy of the original invoice must be included.
- The part must be in or with the original manufacturers packing if applicable.
- Returns for credit must be made within 30 days.
- Warranty merchandise is at the sole discretion of the manufacturer. We will only credit or replace after the manufacturer approves it. Freight to the manufacturer will be billed to you.
- Special orders cannot be returned.
- Returned goods are subject to a 20% restocking fee and/or a rebox charge.
